# Update on DonorsChoose Donations by SF Valley Audubon Society

As we announced in the last *Phainopepla*, the SFVAS Board authorized a total of \$5,000 to be allotted toward donations through this website to classrooms in our area whose teachers make bird-oriented requests for classroom materials.

Since DonorsChoose doesn't fund requests that are granted near the end of the school year, we only had a few applications, not all from the SF Valley. As summer comes to a close and teachers start to gear up for the new school year, we hope there will be many more local requests like the ones we did help to fund.

So far, we have helped Mrs. Fernandez at Robert Frost Middle School in Granada Hills purchase 40 *Birds of Southern California: A Guide to Common & Notable Species (Quick Reference Guides)*, 10 *Mac's Field Guide To Southern California Park and Garden Birds (Mac's Guides (Flash Cards))* and a copy of "Winged Migration." In her thank-you note, Mrs. Fernandez wrote: "I cannot thank you enough for providing an opportunity to allow my students to become aware of the wonders in their world through being engaged in bird watching. You have made a difference for my students. There will be smiles and wonderment as we search to study local and migrating birds." This is exactly what we're after!

We helped Mrs. Wong at Gates Elementary School (in Los Angeles, not strictly in our area, but her request was too spot-on to deny) to acquire plush birds with authentic bird sounds and several copies of National Geographic Kids Bird Guide of North America for her kindergartners and first graders. Get 'em while they're young! In her thank-you note, Mrs. Wong wrote: "Three tweets for San Fernando Valley Audubon Society for funding our project! This is such a great way to culminate our animals integrated unit!"

We helped Mrs. Yokoyama, also at Gates, to buy plush birds, bird books and birdhouse building kits for her youngsters. In her thank you note, she wrote: "Thanks to the San Fernando Valley Audubon Society, we have a great opportunity to learn about birds! There was a large poster included in our bird book so that is displayed on our bulletin board. My students will work in groups to research 1 plush bird they received. They will make an oral presentation and culminate the lesson with their creative birdhouse."

So far, our original donation allotment has been drawn down to \$4,161.88 and it seems the expense has achieved its desired results. As more requests come in, we'll be a bit more disciplined about keeping project funding in our area, i.e. the Valley. Hopefully by the time the next *Phainopepla* comes out, we'll have granted more requests and more teachers will have added -- at our urging and with our help -- bird-centric elements to their curricula.

I urge our members to go to www.donorschoose.org to get a feel for the wonderful resource they provide our hardworking educators.

#### **Grants and Scholarships AVAILABLE!**

Our chapter is always looking for ways to help other people enjoy the glories of birding and to enhance the environment so that birds can continue to thrive in this world. Recent climate problems have made it difficult for many species, especially in view of our drought.

We are offering annual Scholarships of up to \$1000 for a young person(s) (school age or student(s)). The scholarship could be used to attend a birding camp, a conference, or to defray expenses on a special birding trip. The application form is on our website <a href="https://www.sfvaudubon.org">www.sfvaudubon.org</a>. The recipient(s) will be expected to give us a short report on the activity attended and we would also publish that in the *Phainopepla*. Applications are invited in September and the decision will be made by mid-October.

We also are offering five grants a year of up to \$200 each. This can be used in a variety of ways, examples might include planting a bird friendly garden or creating an environment conducive to seeing birds in a public place (maybe a school or maybe a senior citizen center or maybe...) or purchasing and installing a bird box to help a species with successful breeding. The ideas are yours! Our Grants Committee will meet in October and April and will review all applications that come in between meetings at that time. The decisions will be made by the end of October and April.

# **Brewer's Blackbird Harassing Great Blue Heron**

SFVAS member Jordan Kirschner has been drawing and painting most of his life. Although he is relatively new to bird



photography, he clearly brings an artist's eye to this photo. "After purchasing a new camera last November, I was instantly drawn to wildlife shooting, and bought a macro and telephoto lens. Since then, I have frequented different locations (The Arboretum, Santa Monica, Malibu Creek State Park, Will Rogers, Huntington Library, and several other botanical gardens), connecting with nature, and capturing various birds, flowers and other wildlife. I love photographing herons, phoebes, towhees, and any other bird that will sit still for a second, or who I am lucky to capture in flight."

Jordan, who lives in Sherman Oaks, considers the Japanese Gardens to be a local gem. "I was almost done with my tour of the garden for the day when I spotted the Great Blue Heron high up in the tree. I set up my camera and began shooting, which is when I noticed the Brewer's Blackbird continually stalking it, circling and dancing around the heron, which seemed to be frozen in a serious pose. This went on for quite a while."

#### Monthly Field Trip Reports for May and June by Richard Barth

We birded Walker Ranch in Placerita Canyon on May 9. Our little group found most of the species expected here for this date. Costa's Hummingbird, Olive-sided Flycatcher, Lazuli Bunting, Steller's Jay, Ash-throated Flycatcher, Black-headed Grosbeak, White-breasted Nuthatch, Hutton's Vireo, Western Wood-Pewee, Pacific-slope Flycatcher, Yellow Warbler, Wilson's Warbler, Western Tanager, Acorn Woodpecker, House Wren, Nuttall's Woodpecker, Western Bluebird, Warbling Vireo and Spotted Towhee were present and accounted for. A species not often seen when we visit here is Bell's Vireo, but we found one foraging in the riparian willows. The nomadic Phainopepla is an interesting find wherever it shows up. Oak Titmouse is a "can't miss" species in the canyon. Swainson's Thrush and Hammond's Flycatcher made our list as they have on most of our past May visits.

June 13 marked our trip to Rancho Sierra Vista Preserve near Thousand Oaks. The number of birds seemed to be down this year at the preserve, unless we were just unlucky in our search. Ash-throated Flycatcher did not disappoint, however, and we were pleased to pick up Lawrence's Goldfinch for the first time in memory on this trip. Wrentit, Bullock's Oriole, Pacific-slope Flycatcher, Spotted Towhee, California Thrasher (heard), Western Bluebird, Common Yellowthroat and Black-hooded Parakeet were tallied. Among our target species, Blue Grosbeak was easily seen but Lazuli Bunting was uncooperative. Cliff Swallow showed very well and we had good looks at House Wren, Lesser Goldfinch, Cassin's Kingbird, Say's Phoebe and Song Sparrow.

Are You Living with a Killer?

The domestic cat, like its larger cousins in the wild, is a territorial creature. The size of its territory is a function of its food supply: the more food that is available, the smaller its territory needs to be. Where food is available on a regular basis and at the same place, as in a household, a cat's territory is likely to be small areas within the house itself. Domestic cats then do not need to be wandering loose outdoors and there are very good reasons to keep them indoors. Roaming cats are food for larger predators and they are also vulnerable to contagious diseases and being killed by cars. They are also the greatest threat to our bird population, killing HUNDREDS OF MILLIONS of birds each year. Even well fed cats will do this, as the instinct to hunt is distinct (in the cat's brain) from the need to eat. The feral cat population can be kept in check if there are larger predators in the area, but if that is not the case and/or if well-meaning people help to

sustain the feral cat population, that worsens the problem for our birds.

We can protect our feline friends and our birds by not letting kitty wander outdoors. A fresh air experience can be provided, if necessary, by an enclosure outdoors, a screened porch or window, or training kitty to walk on a leash. Kitty and our birds will thank you!

#### RIM OF THE VALLEY CORRIDOR SPECIAL RESOURCES STUDY

The official period for public comments on the National Parks Service (NPS) Rim of the Valley Corridor Special Resources Study (the Study) ended on June 30, 2015. The Study described four options for expansion of the Santa Monica Mountains National Recreation Area (SMMNRA):

Alternative A - No expansion

Alternative B – Cooperative conservation plan

Alternative C – Boundary adjustment to the SMMNRA to provide more recreational opportunities, protection of resources and habitat

Alternative D – Same as C with much more area covered, providing authority for NPS to provide technical assistance to surrounding communities, agencies and landowners to maintain habitat connectivity, protect resources and plan for new parks and trails.

The San Fernando Valley Audubon Society (SFVAS) conservation committee provided a letter of comment to the NPS strongly supporting Alternative D. We are especially encouraged by Los Angeles Mayor Garcetti's strong support not only of Alternative D but also of an expansion to the alternative to include all the tributaries of the Los Angeles River.

During this post-public comment stage of the study process, NPS will revise the report, as needed. The final step in the special resource study process is transmittal of the final report from the Secretary of the Interior to Congress after review by the Office of Management and Budget, along with a recommendation regarding the Secretary's preferred management option for the area. Implementation of any of the recommendations in the report is a separate process, whether by private, local, state or federal actions, or some combination.

SFVAS, as a member of the steering committee of the Rim of the Valley Coalition, will continue to work on advocacy for the eventual enactment of legislation expanding the boundaries of the SMMNRA. *By Pat Bates*

The recent release of findings from the American Lung Association about the dangers of air pollution in California puts more urgency into current legislative efforts to reduce carbon pollution. While air pollution in the form of greenhouse gas emissions is the leading cause of global warming, air pollution is also a major threat to public health, as well as the health of our birds and environment. We need to be able to breathe clean air if we are to truly enjoy the natural wonders of California.

Audubon California is supporting a legislative package moving through the California State Senate aimed at addressing the problem of carbon pollution and air pollution. Prominent among the bills in the package are Senate Bill 32, which would expand California's current climate pollution reduction target to 80% below 1990 levels by 2050, and Senate Bill 350, which calls for a 50% reduction in petroleum use in cars and trucks, a 50% increase in energy efficiency in buildings, and a goal of 50% of state utilities' power coming from renewable energy, all by 2030.

# How can we enjoy birds and nature if it's unhealthy to breathe the air outside? Submitted by Audubon California

Audubon's own research shows that global warming caused by carbon pollution will threaten 170 California bird species in the coming decades. This includes iconic birds including: Brown Pelican, Golden Eagle, Allen's Hummingbird, and the Yellow-billed Magpie, to name just a few.

But the American Lung Association's 2015 State of the Air Report makes it clear that the stakes are high for Californians, as well:

- Seventy percent of Californians (28 million residents) live in counties affected by unhealthy air.
- Eight California cities appeared among the top-ten most polluted metro areas in the nation for ozone and particle pollution. (Bakersfield, El Centro, Fresno, Hanford, Visalia, Los Angeles, Modesto-Merced, Sacramento, San Francisco Bay Area).
- All 8 San Joaquin Valley counties experienced higher numbers of unhealthy particle days, and received a failing grades.
- The Los Angeles metro area remains ranked among the five most polluted in the nation for ozone and short-term and annual particles. Parts of the Los Angeles region experience more than 100 unhealthy ozone days per year.

#### How your donations are used:

The San Fernando Valley Audubon Society (SFVAS) is an all-volunteer §501(c)(3) organization. We rely on donations received in the Birdathon to fund the Sepulveda Basin Environmental Education Program (SBEEP). Other donations, membership receipts, and investment income fund the remaining portion of SBEEP expenses as well as all our other environmental, educational and outreach activities.

The amount of revenue SFVAS receives from the National Audubon Society only covers about 42% of the cost of preparing and mailing our newsletter, the *Phainopepla*. The cost of printing and mailing the *Phainopepla* is significant, and only partially mitigated by receipt of local dues. That said, the *Phainopepla* is a very important source of Chapter information including bird walk and other event schedules, information on local conservation and environmental issues, and other items of interest to the community. Your donations help fund this valuable community resource.

SBEEP is a wonderful program, providing local students in grades 4–6 with field trips led by trained naturalists. The students receive hands-on instruction in observation of wildlife and environmental issues, using binoculars and microscopes provided by SFVAS. Each year, approximately 2,000 children (and their teachers) participate in this program. The annual Birdathon is the primary source of funding specifically earmarked for SBEEP—we thank you for your donations to the Birdathon and throughout the year!

#### **Introducing Merlin Bird Photo ID**

The Cornell Lab of Ornithology has been working on a new bird photo ID feature for the Merlin app, and we're ready for you try it on our test website! Just upload a photo, click on the bird's bill, eye, and tail, and let computer vision help you ID the bird. It currently recognizes 400 common North American bird species. Because it's powered by machine learning techniques, it gets "smarter" the more people use it. Help us improve the accuracy so we can add it to the Merlin app some day! Try Photo ID.
